BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. ("BellSouth") pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. On June 18, 2001, Supra Telecommunications & Information Systems, Inc. ("Supra") filed its "Status and Complaint Regarding BellSouth's Bad Faith Negotiations Tactics" [sic]. Attached to the Complaint as Exhibit B is a draft Agreement that includes language proposed by Supra.

2. Exhibit B contains substantive references to a commercial arbitration award dated June 5, 2001. Both BellSouth and Supra are bound by the existing Interconnection Agreement to keep the results of the arbitration confidential. Since the public release of this information is contractually prohibited, it is entitled to confidential classification pursuant to § 364.183, Florida Statutes.

3. Because this information is proprietary, BellSouth is now filing this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code. Supra gave BellSouth no notice of its filing of this confidential information. Thus, it was only upon reviewing the subject document that BellSouth first discovered that it contained confidential information. BellSouth is filing this notice promptly after making this discovery. BellSouth also promptly contacted counsel for Supra (on June 5, 2001) regarding its disclosure of this information, and requested that Supra agree to stipulate to treat this information as confidential. Supra refused to do so.

4. The original of this notice has been filed with the Division of the Commission Clerk and Administrative Services, and a copy has been served on all parties of record.
