BELLSOUTH'S NOTICE OF CORRECTION TO RESPONSE TO SUPRA'S COMPLAINT AND MOTION TO DISMISS

BellSouth Telecommunications, Inc. ("BellSouth") hereby files its Notice of Correction to Response to Supra's Complaint and Motion to Dismiss and states the following:

- 1. The Notice is being filed to correct certain errors in BellSouth's Response to Supra's Complaint and Motion to Dismiss. All of these errors appear in the lists of the issues that have been withdrawn, that have been discussed and that Supra has refused to discuss. These lists appear on page seven of the Response.
- 2. Issue 64 has been withdrawn, but was not included in the list of withdrawn issues in footnote 3, page 7. Also, Issue 46 was erroneously listed as having been withdrawn, when, in fact, Issue 46 is one of the issues that has not been settled, and that Supra has refused to discuss.
- 3. Issue 38 was erroneously listed among the issues that Supra has refused to discuss. In fact, issue 38 has been discussed and resolved. Issue 39 should have been included in the list of issues that Supra has refused to discuss, but it was not included.
 - 4. Thus, with these corrections, the issues are as follows:
 - 1) Withdrawn Issues: 6, 30, 36, 37, 43, 50, 54, 56, 58 and 64.
