BY THE COMMISSION:

On March 27, 2001, Order No. PSC-01-0806-FOF-TP, Final Order on Petition for Arbitration (Final Order) was issued in Docket No. 000907-TP. At the May 29, 2001, Agenda Conference, we approved the arbitrated interconnection agreement in that same docket. On June 18, 2001, the previously issued Final Order was erroneously transmitted to the Division of the Commission Clerk and Administrative Services for issuance instead of the Order Approving Arbitrated Interconnection Agreement. Due to this transmission error, the Final Order was reissued and assigned Order No. PSC-01-1332-FOF-TP.

ORDERED by the Florida Public Service Commission that Order No. PSC-01-1332-FOF-TP is vacated. It is further

ORDERED that Order No. PSC-01-0806-FOF-TP shall remain in full force and effect.
