Dear Mr. and Ms. Nelson:

Thank you for your letter dated August 27, 2001, regarding the application filed in the above-referenced docket. In your letter, you indicated that you object to the merger of Nuon Acquisition Sub, Inc. with Utilities, Inc. and wish for the Commission to disapprove the merger.

While I am not in a position to answer many of your questions regarding the company's intent with respect to the merger, I would like to note that all the company's filings with the Commission are online at www.psc.state.fl.us. Click the "filings and dockets" box, "Dockets" line, and enter 010887 as the docket number. If you do not have access to the internet at home, many public libraries have internet access available. I can state that the company has not filed any paperwork to increase your water rates, and that a separate proceeding would need to be conducted before the company could raise your rates.

This Commission will consider your concerns when reviewing the application to determine if approval of the merger is appropriate. However, the Commission needs to know your intent regarding your objection to this application. If you choose to go beyond making your objection known and to pursue the objection, you may request a formal hearing, which will be scheduled and at which you will be required to provide formal testimony and other evidence to support your protest. Although the Commission allows individuals to represent themselves at hearing, you may wish to hire an attorney to represent you.

Please advise this Commission by September 19, 2001, if you intend to pursue your objection and wish to request a formal hearing.
