Pursuant to this letter, Florida Power and Light Company ("FPL") respectfully requests a deferral of Item 3 scheduled for the September 18, 2001 Agenda Conference, involving a staff recommendation issued in the above-referenced docket. The staff recommendation addresses a proposed rule on the subject of interconnection of small photo voltaic systems. To my knowledge, there are no critical dates associated with the proposed rule.

This deferral request arises from the fact that FPL's subject matter experts, Bob Valdez and Gus Dominguez, will not be able to appear at the September 18, 2001 Agenda Conference.
