

Dear Lorena:

I am writing as a follow up to our recent conversations concerning the deposition of Mr. Watford, Mr. Nixon and Mr. Porter, specifically on the issues concerning rate structure and the inclining block rates that were outlined in Ms. Jennie Lingo's memo which you sent me and which is attached.

We at Aloha agreed to these initial depositions and to allow later depositions of these witnesses only under the condition that the areas to be covered in this initial deposition would not be repeated by any party in the later deposition, and that you would obtain the agreement of Public Counsel in that regard. The areas which are to be covered in the first deposition and to which that deposition is limited, are outlined in Jennie Lingo's attached memo. Therefore, based upon the fact that we have moved forward with setting these depositions up for October 4, 2001 at Mr. Nixon's office, I assume all parties have agreed. I am writing this letter to ensure that there is no question of that agreement.

## ISSUES FOR LIMITED DEPOSITION

- Issue 1: What is the appropriate method of projecting customers and consumption for the projected test year ending December 31, 2001, and what are the resulting projected numbers of customers and consumption for the 2001 projected test year before any adjustments are made?
- Issue 2: What conservation programs are appropriate for this utility?
- Issue 3: What is the appropriate level of conservation expenses?
- Issue 4: What is the appropriate resulting reduction in total consumption?
- Issue 5: What is the appropriate projected number of purchased water gallons from Pasco County, and what is the resulting expense?
- Issue 6: What is the appropriate rate structure for this utility?
- Issue 7: Is repression of consumption likely to occur, and if so, what is the appropriate adjustment and the resulting consumption to be used to calculate consumption charges?
- Issue 8: What are the appropriate monthly rates for service?
