## Florida Water Price Elasticities (Source: SWFWMD Price Elasticity Study, 1995)




Figure 1. Price elasticity curves for SWFWMD single family customers with property values above and below \$64,000 using the PRICE(2) price specification with a natural exponential composite functional form.
