



On Monday, August 16, my office received a filing from you on behalf of ITC^DeltaCom Communications, Inc. The filing consisted a Notice of Intent to Request Confidential Classification of Exhibit MT-2 to the direct testimony of Michael Thomas and of Exhibits TAH-1 through TAH-3 to the direct testimony of Thomas Hyde. The confidential exhibits accompanied the notice of intent. Prior to placing the confidential exhibits in locked storage, Exhibit MT-2 was stamped with identifying document number 09687-99, and Exhibits TAH-1 through TAH-3 with 09688-99.

During further processing of the confidential documents on August 19, Document No. 09687-99 (Exhibit MT-2) was inadvertently discarded. I have investigated the events that led to this unfortunate situation and can assure you it was clerical error and not a malicious act. We take the loss of this confidential document very seriously and have instituted additional safeguards within my Division for the handling of confidential materials.

Subsequent to receipt of the notice of intent, we received on September 2 a request for confidentiality and a "highlighted version" of confidential Exhibit MT-2. The exhibit is identified as Document No. 10533-99. Be assured it will be afforded stringent protection by my office.

Please accept my apology for the inconvenience this may cause you and your client.

This memorandum details the activity surrounding the filing and loss of Confidential Document No. 09687-99, as well as the remedial action taken as a means of preventing such an occurrence in the future.

### BACKGROUND

Document No. 09687-99, Exhibit MT-2 to ITC^DeltaCom witness Michael Thomas's testimony, was filed in Records and Reporting on Monday, August 16, 1999 under a Notice of Intent to Request Confidentiality by attorney J. Andrew Bertron of the Huey law firm in Tallahassee. After document numbering and entry of filing information in the Case Management System, the document was delivered to the Commission Deputy Clerk 1 ("CDC 1") for further handling. Because of the lateness of receipt of the filing and due to the number of other confidential documents received (a total of seven were filed that day), the CDC 1 placed it in storage in the confidential room for later handling.

Normally, the CDC 1's practice was to handle any confidential filings received the previous day as soon as possible on the next work day. However, because she had already scheduled a project to begin the morning of August 17, she delayed handling of the confidential filings until completion of the project on Thursday, August 19. Again, because of the volume of confidential documents to be handled, partial processing of the documents ("partial processing" in this case was preparation and distribution of notices to staff that each of the documents had been filed) was not completed until Friday, August 20.

On Tuesday morning, August 24, the CDC 1 again removed the confidential documents (which by this time included not only the seven filed on the 16th but six others that had been filed during that week and on the 23rd) from storage to complete processing. At this point, the documents were to be manually logged in on the control file and placed in marked pouches in the storage drawers. It was during this exercise that the CDC 1 realized she did not have in her possession confidential Document No. 09687-99.

The CDC 1 immediately notified her Commission Deputy Clerk Supervisor ("Supervisor"). The two then undertook a search through the confidential files for the documents, which included contacting staff to determine if the document had been mistakenly sent—along with a copy of the

notice concerning filing—to the staff person assigned. When their search did not turn up the document, I was advised of the situation.

At my request, the CDC 1 and Supervisor searched through the confidential filings again, and also searched through non-confidential filings (including copies of non-confidential documents that would have been placed in the Commissioners' files by the CDC 1) that had been filed on and after August 16. Again, the search was fruitless. At that point, the CDC 1 concluded that Document 09687-99 was inadvertently discarded in her recycling bin along with extra copies of the notice of intent that accompanied it.

It was after this second search on Tuesday afternoon that the Supervisor and I presented the situation to you. During discussion of the situation, we decided to explore the possibility that the document *had* been placed in the recycling bin and subsequently moved to the recycling dumpster outside the Gunter Building. The Supervisor and I went to the dumpster, removed all plastic bags of recycled papers from it, and went through each bag in an attempt to locate the document. After an extensive search, we had to conclude that the dumpster contained no recycled paper from our Division.

The Supervisor then contacted Meridian Management for more information on the recycling process. She learned that paper from the Easley Building was placed in a dumpster across the street from our building, and that it was picked up on Tuesdays and Thursdays. Believing it might be possible that the discarded confidential document was still in the dumpster, the Supervisor and I—accompanied by you—located the group of three dumpsters and undertook a search of the paper in them. While we did locate recycled material from the Division of Consumer Affairs, we were unable to locate any bags containing paper from our Division, and, after more than an hour of searching, concluded the missing document was not in any of the dumpsters. This conclusion was confirmed by a Meridian Management worker, who advised us as we were leaving that all material had been picked up from the dumpsters that morning and taken to the recycling center for further processing.

On Wednesday morning, August 25, at your request, I searched page by page through all confidential documents that had been filed in August while the Supervisor again searched through docket files and Commissioner files. Staff who had checked out confidential material after August 16 were also contacted in the event the document had inadvertently been slipped into those documents while the documents were still in our Division. Unfortunately, this additional effort did not turn up Document No. 09687-99.

After these extensive searches, I had to agree that Document No. 09687-99 was mistakenly discarded as recyclable paper along with extra copies of the notice of intent that accompanied it.

On September 2, 1999, pursuant to procedures for filing requests for confidentiality set out in Rule 25-22.006(4), F.A.C., Mr. Bertron filed a highlighted version of Document No. 09687-99. This document was stamped with identifying Document No. 10533-99. After completing all procedures required when logging in and securing confidential documents, Document No. 10533-99 was placed in confidential storage in our confidential room. It will be made available for authorized staff to sign out, and may also be marked as an exhibit in the hearing which is scheduled for October 27 through 29, 1999. If it is entered in the record as an exhibit, an order ruling on its confidential status will be issued by the prehearing officer in the docket. If it is not entered in the record, it will be returned to Mr. Bertron after the docket is closed. While it remains at the Commission, it will be afforded confidential handling in accordance with our procedures at all times.

Attached to this memorandum is a proposed letter to Mr. Bertron advising him of the loss of Document No. 09687-99. I will finalize it for your signature when advised to do so.

### **REMEDIAL ACTION**

Before presenting the situation to you on August 24, the Supervisor and I talked with the CDC 1 about the reasons for her delay in handling this document and the others that were filed on August 16. We also discussed the high priority that must be assigned to the handling of confidential documents, as well as the importance of completing all steps in the handling process in order to avoid the kind of mistake that occurred with Document No. 09687-99. We then advised her that we would present the details of the situation to you as our next step in attempting a resolution.

After our search on Wednesday morning, August 25, proved fruitless, we met again to discuss ways to avoid a similar occurrence in the future. We examined the areas of responsibility and workload that the CDC 1 handled and concluded that, with the increasing volume of confidential filings and with the number of other day-to-day responsibilities of the CDC 1, it was not possible for her to give the confidential filings the focus they needed. It was decided to streamline some processes and reassign certain duties to the Records Technician position, which was being vacated on August 27. The proposed changes were discussed with the CDC 1 on August 25. She was assured that the changes were in no way a punitive action against her, but were being proposed as a means of elevating handling of confidential documents to the priority level they required, and placing the responsibility with a position that had a workload level which would allow this. She concurred with the changes on August 26, and they were announced to the Division by e-mail on that date. A copy of the e-mail is attached.

As can be seen on the attached position description, handling of confidential documents will now be the primary focus of the Records Technician. Once the position is filled, the CDC 1 and I will work closely with the incumbent to ensure that he or she fully understands the procedures (including those laid out in RAR's SOP 2050 and in the PSC's APM 11.04) for handling Memorandum dated September 3, 1999 Confidential DN 09687-99 filed in 990750-TP Page 4
