The Commission received your letter dated January 8, 2002, requesting cancellation of the company's Interexchange Carrier certificate. A voluntary cancellation is normally granted if the company is in good standing with the Commission and does not have a past due balance of the Regulatory Assessment Fee (RAF), including statutory penalty and interest charges. If a company is <u>not</u> in good standing and has an outstanding balance of the RAF, the Commission normally cancels the certificate on its own motion for a rule violation. It should be noted that any balance owed is forwarded to the Comptroller's Office for collection.

The RAF, which is .0015% of a company's intrastate revenues or \$50.00, whichever is greater, is assessed if a certificate is active for any one day during a calendar year. The RAF is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. If payment for the RAF is mailed after the due date, then statutory penalty and interest charges are applicable.

According to Commission records, your company has an outstanding balance for the 2000 RAF. Our records show that the company paid \$0.35 on January 30, 2001 (your check #10580) instead of the \$50.00 minimum. This means the company owes \$49.65 RAF, \$12.41 penalty, and \$6.45 interest, for a total of \$68.51.
