

AT&T is a telecommunications company that has been duly certificated by the Commission as an alternative local exchange telecommunications company ("ALEC") and an interexchange company ("IXC") in Florida. As such, AT&T is subject to the rules, regulations and orders of the Commission, and such rules, regulations and orders impact AT&T's ability to provide local exchange telecommunications service and intrastate interexchange telecommunications service.

4. As an ALEC, AT&T must utilize the operations support systems and other facilities of incumbent local exchange companies in order to provide local exchange service. Accordingly, AT&T's substantial interests will be affected by any action that the Commission takes in this docket.
