Pursuant to staff request, I am writing to provide an explanation regarding Trans National Communications International, Inc.'s failure to file its ALEC RAF reports. The company initially obtained IXC authority in the State of Florida. When the company obtained its IXC authority, it entered into an agreement with an outside service company to complete necessary reports to retain its IXC certifications. The company later decided to obtain ALEC authority in several states, and its contract with the outside service company was amended to include ALEC filings. Due to an operational error within the outside service company, the amendment to add ALEC filings was never communicated to the analyst which was responsible for the company's reports, therefore the company's ALEC reports were not timely filed. Due to a change in management, the notices from the Commission regarding the delinquent reports were not properly handled, and "fell through the cracks". The situation with the outside service company has been rectified, and all future reports should be timely filed.
