

**ALEC COALITION'S COMMENTS CONCERNING
STAFF'S PROPOSED TABLE OF AGREED ISSUES**

The ALEC Coalition¹ hereby submits its comments concerning Staff's proposed Table of Agreed Issues dated October 22, 2002.

The Table of Agreed Issues seeks to capture the issues upon which the ALEC Coalition and BellSouth agreed at the workshops held in this docket on September 25 and 26, 2002 and October 17 and 18, 2002. The ALEC Coalition acknowledges that the Table of Agreed Issues accurately states the issues upon which the parties agreed. The ALEC Coalition notes that in some cases the agreement is stated in shorthand form, and that the substance of what was proposed and agreed upon must be determined by reference to the comments of the party that submitted the proposed change. The ALEC Coalition also would clarify the agreements with respect to the following items:

BellSouth Proposed Changes 52, 53, 55, 56, 68, 60-62 and 64-66: The ALEC Coalition agrees to the addition of the term "customer" in the SQM sections BellSouth proposes, but with the understanding that these changes will not result in the exclusion of
