- 8. BellSouth objects to each Interrogatory insofar as it is unduly burdensome, expensive, oppressive, or excessively time consuming as written.
- 9. BellSouth objects to each Interrogatory insofar as it is not limited to any stated period of time and, therefore, is overly broad and unduly burdensome.
