

Pursuant to the Commission's July 19, 2002 Order in the above-referenced docket, BellSouth Telecommunications, Inc. ("BellSouth") respectfully provides notice of a change being made to address an exception issued by KPMG Consulting Inc. ("KCI") in connection with the third-party test. This change addresses an issue identified in Georgia Exception 152, which concerns raw data for the Percent Provisioning Troubles Within 30 Days of Service Order Completion metric. Currently, the "number of items worked on" field in the Raw Data Mart is incorrect, although the posted results for this metric are correct. BellSouth will be correcting this raw data error effective with October 2002 performance reports. Because this change will only affect raw data, it will have no impact on performance results.
