RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2000, 2001, and 2002 for Global Telephone Corporation d/b/a Global Telephone International, Inc. (TI617).

On September 10, 2002, Docket No. 020967-TP was established to address Global Telephone Corporation d/b/a Global Telephone International, Inc.'s (Global Telephone) request for cancellation of its Interexchange Telecommunications (IXC) certificate due to Chapter 7 bankruptcy. By Order No. PSC-02-1540-PAA-TP, issued on November 12, 2002, the Commission approved the cancellation of Global Telephone's IXC Certificate No. 4809. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs, including penalty and interest, for the years 2000, 2001 and 2002 for Global Telephone.
