Re: Aloha Utilities, Inc. (Aloha), Docket No. 010503-WU, Your E-Mail Dated November 25, 2002, Concerning Black Water and Discolored Water Coming From the Taps in Your House

Dear Mr. Wood:

I have been asked to respond to your e-mail dated November 25, 2002, which was received by our Consumer Affairs Division and assigned Tracking No. 0005721. In that e-mail, you complain about the water being "black" and discolored, and having metal particles in it. I can appreciate your frustration with your continuing problems with either discolored or "black" water.

As you know, the Commission issued Order No. PSC-02-0593-FOF-WU on April 30, 2002. Among many other things, that Order required the utility to make improvements to Wells Nos. 8 and 9, and then to all its wells, to implement a treatment process designed to remove at least 98 percent of the hydrogen sulfide in its raw water. Such improvements to all of Aloha's Seven Springs water system were to be placed into service by no later than December 31, 2003, and were designed to alleviate the "black water" problem. However, Aloha appealed that Order, and pursuant to Order No. PSC-02-1056-PCO-WU, issued on August 5, 2002, the requirement to make these improvements was stayed pending the outcome of the appeal. Therefore, the Commission must wait for the First District Court of Appeal to render its decision before taking any further action on requiring Aloha to make improvements to reduce hydrogen sulfide and the tendency of the water to produce copper sulfide (the black particulate in the water).
