We got a letter from Patton Boggs law firm today asking us to cancel this company's ALEC and IXC certs. Letter says:

Pursuant to an order entered by US Bankruptcy Court for Southern District of NY on 11/15/01, in Chapter 11 Case 01-12974(SMB), certain of Easton's assets, including Easton's FL customer base, were sold to and were assumed by Weston Telecommunications, LLC as of 11/16/01.

Accordingly, because Easton is no longer an operational provider of any services to FL customers, it hereby requests cancellation. Similarly, because Easton had ceased all telco operations in FL prior to year-end 2001 and will not be an operational entity going forward, it has not filed an annual report for that year.
