Wayne, as I understand it, you're wanting to reissue a PAA order as an order approving settlement (I know this is one of those I sent you an e-mail on earlier). No. 1, we can't do that because we use "PAA" as the order designator for PAAs and "AS" for orders approving settlement--thus we couldn't reissue a PAA as an AS.
