Attached is the above referenced letter from BellSouth introducing the BellSouth Unlimited Answers Plan Promotion. Is the \$49.99 monthly fee referenced in your local exchange tariff? Is so, where? If not, why not?

RESPONSE: No, the Complete Choice Service is in the local exchange tariff and the two BellSouth Long Distance promotions are in BellSouth Long Distance's long distance tariffs. "BellSouth Unlimited Answers Plan" is not filed in a single tariff, but is the name chosen for a bundle of local and toll services.

> The \$49.99 represents the combined price for jointly marketed BellSouth ("BST") local exchange services and BellSouth Long Distance interstate and intrastate long distance services. The tariff references and related prices are below:

REQUEST:

The coupon associated with the Unlimited Answers Plan Promotion states that orders placed between February 15 and May 15, 2003, for BellSouth ("BST") local phone service qualify for this promotion. According to T-030132, first revised page 35.5.2.16, the effective date is February 20, 2003. Please explain why the dates differ.

RESPONSE: The \$75 Cash Back Promotion is associated with BellSouth Complete Choice and BellSouth Preferred Pack. The cash-back promotion was created with a 2/15/03 effective date. Due to miscommunication between the various BellSouth teams involved in the filing, the change in the effective date from 2/15/03 to 2/20/03 was not incorporated in the promotion collateral or operations. To prevent this from occurring again, a new process to verify promotion start dates is being established between the corporate filing team and the marketing group.

REQUEST:

The language stated on the coupon associated with the Unlimited Answers Plan Promotion may be inconsistent with the language stated in your exchange tariff. The coupon states that cancelled orders are not eligible for any cash-back offer, whereas the language in T-030132 states that customers that have not had service with BellSouth within the last 17 days qualify. Please clarify and, in particular, explain what constitutes a "cancelled order" for purposes of the coupon.

RESPONSE: The language contained in the \$75 Cash-Back Coupon stating "[C]ancelled orders are not eligible for any cash-back offer" refers to eligibility for the cash-back offer once the customer has accepted the offer and agreed to return his service to BellSouth. If the customer cancels his order (e.g. cancels the service that qualified them for the cash-back offer prior to BellSouth rendering its first bill or disconnects their service) after he has returned to BellSouth with this offer, then he is not eligible to receive the \$75 cash-back. The customer must keep his service to receive the \$75 cash-back.

> The exchange tariff language is in reference to the initial eligibility requirements, stating that in order for a potential customer to qualify for the promotion, he must have not had service with BellSouth within the last 17 days. This is an eligibility requirement to qualify for the offer.

RESPONSE: A spreadsheet that provides the requested analysis for the BellSouth Telecommunications, Inc. services offered under T-030132 is attached as page 2 and is proprietary.

The analysis demonstrating the intrastate Long Distance portion of the \$49.99 bundled price is compensatory and is attached as page 3 and is proprietary.

The BellSouth Long Distance portion of the Unlimited Answers Plan Promotion includes the BSLD Promotion #14 for intrastate long distance calling, as well as a separately rated corresponding interstate long distance calling service. The long distance services in this promotion are offered only in conjunction with certain local telephone services offered by BellSouth Telecommunications.
