Payment for the 2002 Regulatory Assessment Fee was due January 30, 2003. As of this date, payment has still not been received. A delinquent notice was mailed on February 21, 2003, via certified mail, which was signed for and delivered. On April 28th, I wrote you and explained that payment had not been received and enclosed a copy of the 2002 Regulatory Assessment Fee return form.

Also on April 28<sup>th</sup>, the Commission received a letter requesting cancellation of your IXC certificate. Before staff can recommend a voluntary cancellation, a company must not have any past due balance and must either pay the current year's fee (in this case 2003) or provide a date certain the fee will be paid.

The fee is .0015% of a company's intrastate revenues, or \$50.00, whichever is greater. The fee is due even if a company never started operations or had any revenues. In addition, statutory penalty and interest charges are applicable since payment is late. This means that if you owe the minimum, the total due if postmarked by July 29th is \$125.22, which includes prior years' balances plus the 2003 minimum fee.
