Attached is a letter from Aloha Utilities, Inc. outlining the changes which have occurred in the last 30 days on the refund reporting. All of the credit refunds have previously been reported to the Commission and no changes have occurred therein. The only thing outstanding are those checks for customers no longer in the system. Out of the approximately 1,701 checks issued, 1,357 have now cleared, 263 are outstanding and 81 checks have been returned as undeliverable with no further forwarding addresses available.

Based upon the above, the Utility has completed the refund with the exception of the 263 outstanding checks totaling \$1,182.27. Once the next bank statement is received indicating which of these checks remain outstanding, the Utility will file a final refund report shortly thereafter (sometime in December) proposing final disposition of these monies, along with the 81 checks already returned. With that filing, the refund reports will be complete.
