NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELLING COMPETITIVE LOCAL EXCHANGE
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

TeleCents Communications, Inc. (TeleCents), holder of Competitive Local Exchange Telecommunications Certificate (CLEC) of Public Convenience and Necessity No. 7933, has requested the cancellation of CLEC Certificate No. 7933. TeleCents has complied with the provision of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its CLEC certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2002. Accordingly, we find it appropriate to cancel CLEC Certificate No. 7933, effective April 14, 2003. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2003 will be mailed to TeleCents for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2003 shall relieve TeleCents from its obligation to pay RAFs for the year 2003.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that TeleCents Communications, Inc.'s Certificate No. 7933 to provide Competitive Local Exchange Telecommunications services is hereby canceled, effective April 14, 2003. It is further

ORDERED that TeleCents Communications, Inc. shall remit Regulatory Assessment Fees for the year 2003. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this/these docket(s) before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
