

We received your letter dated June 6, 2002, and would like to take this opportunity to address the questions raised in your letter. Your first question asks where is the \$275 dollar tap-in fee addressed in the staff report. Staff has addressed the tap-in fee in Issue No. 14 (page 35). In every staff assisted rate case (SARC), the Commission staff looks at the utility's current service availability fees, in this case the tap-in fee, to determine if the fee needs to be increased, decreased, or discontinued. Staff relies on Rule 25-30.580, Florida Administrative Code, which sets guidelines for service availability charges in order to determine the appropriate service availability fees. In this case, the utility's current tap in fee falls within the guidelines of Rule 25-30.580, Florida Administrative Code. Therefore, at this time, staff has not recommended changing the service availability charge.

Your second question asks is the utility authorized to charge the \$275 charge and if so, where does it appear on the financial report. The utility has tariffs filed with the Commission which outline all the utility's rates and charges that have been approved by the Commission. The utility should also have a copy of these tariffs available. According to the utility's Original tariff sheet No. 17.0, the utility is authorized to collect a \$275 tap in fee. Tap in fees and other service availability charges are designed to offset the cost associated with customer growth. The rational for this is that existing customers should not have to pay for the cost associated with adding new customers, growth should pay for itself. These fees should be recorded on the utility's books in Account 271-Contributions in Aid of Construction (CIAC). CIAC is a reduction to plant investment on the utility's books and is amortized as an offset to depreciation expense.






