# Application for a Rate Increase in Monroe County by Key Haven Utility Corporation

#### Docket No. 020344-SU

On August 14, 2002, Key Haven Utility Corporation (Key Haven or utility) filed an application for approval of interim and permanent rate increases with the Florida Public Service Commission (PSC or Commission). Key Haven provides wastewater service to approximately 419 residential customers in Monroe County. Key Haven is located two miles east of the city of Key West off the Overseas Highway (US 1).

The current rate case is being processed under the PSC's "Proposed Agency Action" (PAA) procedure. Under the PAA process, the case will not be set for a formal hearing unless a timely protest to the Commission's proposed agency action is filed.

On November 19, 2002, the PSC voted to suspend the utility's request for a permanent rate increase, but approved an interim rate increase of \$55,347, in order to allow the utility to maintain financial integrity for the period of the investigation of the requested rate increase. The interim rate increase is subject to refund pending the completition of the Commission's investigation.

On Thursday, December 5, 2002, PSC staff will hold a customer meeting for the purpose of providing customers and other interested persons an opportunity to offer comment and ask questions regarding the utility's proposed rate increase and quality of service.

Currently, the utility's flat rate is \$48.07 per month. The interim flat rate will increase to \$59.11 per month. Key Haven has requested consumption-based final rates, and a residential bill for 8,000 gallons would increase from \$48.07 to \$77.68 for wastewater. In accordance with Florida Statutes, the PSC will consider the utility's quality of service and other matters in this case.

PSC staff is scheduled to make a recommendation to the Commission on February 6, 2003, and the Commission vote on this matter is scheduled for February 18, 2003 Agenda Conference.
