**AMENDMENT TO  
INTERCONNECTION AGREEMENT BETWEEN  
BELLSOUTH TELECOMMUNICATIONS, INC. AND  
KMC TELECOM HOLDINGS, INC.  
DATED OCTOBER 6, 2000**

This Agreement (the "Amendment") is made and entered into between BellSouth Telecommunications, Inc. ("BellSouth"), a Georgia corporation, and KMC Telecom Holdings, Inc. ("KMC"), a Delaware corporation, on behalf of itself and its certificated operating affiliates identified in Attachment A hereto.

WHEREAS, the Parties desire to amend that certain Interconnection Agreement between BellSouth and KMC dated October 6, 2000 (the "Interconnection Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, KMC and BellSouth hereby covenant and agree as follows:

1. Section 3.21 of Attachment 1 of the Interconnection Agreement is hereby deleted in its entirety and replaced with the following language:

"Notwithstanding the foregoing, BellSouth may provide KMC notice via Internet posting of price changes and changes to the terms and conditions of services available for resale per Commission Orders. To the extent that referenced changes to prices, terms and/or conditions would require amendment under the terms of this Agreement, the Resale Internet Posting does not replace the need for an amendment or impact the effective date of such amendment. BellSouth will also post changes to business processes and policies, notices of new service offerings, and changes to service offerings not requiring an amendment to this Agreement, notices required to be posted to BellSouth's website, and any other information of general applicability to CLECs."
2. All other provisions of the Interconnection Agreement, dated October 6, 2000, shall remain in full force and effect.
3. Either or both of the Parties is authorized to submit this Amendment to the appropriate state Commissions for approval subject to section 252(e) of the Federal Telecommunications Act of 1996.

This Amendment shall be made effective upon the date it is signed by both Parties.
