Docket No. 030947-TI - Compliance investigation of Digitec for apparent violation

of Sections 364.02(13) and 364.04, Florida Statutes.

On September 29, 2003, Docket No. 030947-TI was established to address Digitec's violations of Sections, 364.02(13) and 364.04, Florida Statutes. Digitec failed to remit the fine levied by Order No. PSC-04-0413-PAA-TI, issued on April 21, 2004. The Commission further ordered that Digitec should cease and desist providing intrastate interexchange telecommunications service in Florida. The Commission further ordered that the outstanding fine be sent to the Department of Financial Services for collection, and, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to writeoff the uncollectible fine for Digitec.
