

# REVISED APPLICATION FOR AMENDMENT OF CERTIFICATE

## LEGAL NOTICE

Notice is hereby given on JULY 8, 2008, pursuant to Section 367.045, Florida Statutes, of the revised application of Indiantown Company, Inc. to amend its Water Certificate No. 387-W and Wastewater Certificate No. 331-S to add the following territory in Martin County, Florida:

### **PARCEL 1**

In Section 26, Township 39 South, Range 38 East, Commence at the Northwest Corner of said section 26, Thence South along the West line of said section 26 to the intersection with the Westerly Projection of the North line of tract 56, Block B according to the Plat of Indiantown Farms as recorded in Plat Book 1, page 80, Public Records, Martin County, Florida, and the point of beginning; Thence East along the North line of Tracts 56 and 11 and the Easterly projection thereof to the East line of the west one half ( $\frac{1}{2}$ ) of said section 26; Thence South along said East line to the intersection with the Easterly projection of the South line of said Tract 11; Thence West along the South lines of said Tracts 11 and 56 and the Westerly Projection thence of to the West line of the aforesaid section 26; Thence North along said West line to the Point Of Beginning.

### **PARCEL 2**

Begin at the Northwest corner of Section 31, Township 39 South, Range 39 East in the centerline of County Road 609 (SW Allapattah Road); Thence East along the North line of said section 31 to the Northeast corner of said section 31; Thence South along the East line of said section 31 to the intersection with the South line of the North one half ( $N \frac{1}{2}$ ) of the South one half ( $S \frac{1}{2}$ ) of said section 31; Thence West along said South line to the intersection with the West line of said section 31 and the centerline of said County Road 609; Thence North along said West line and centerline to the Northwest corner of said section 31 and the Point Of Beginning.

### **PARCEL 5**

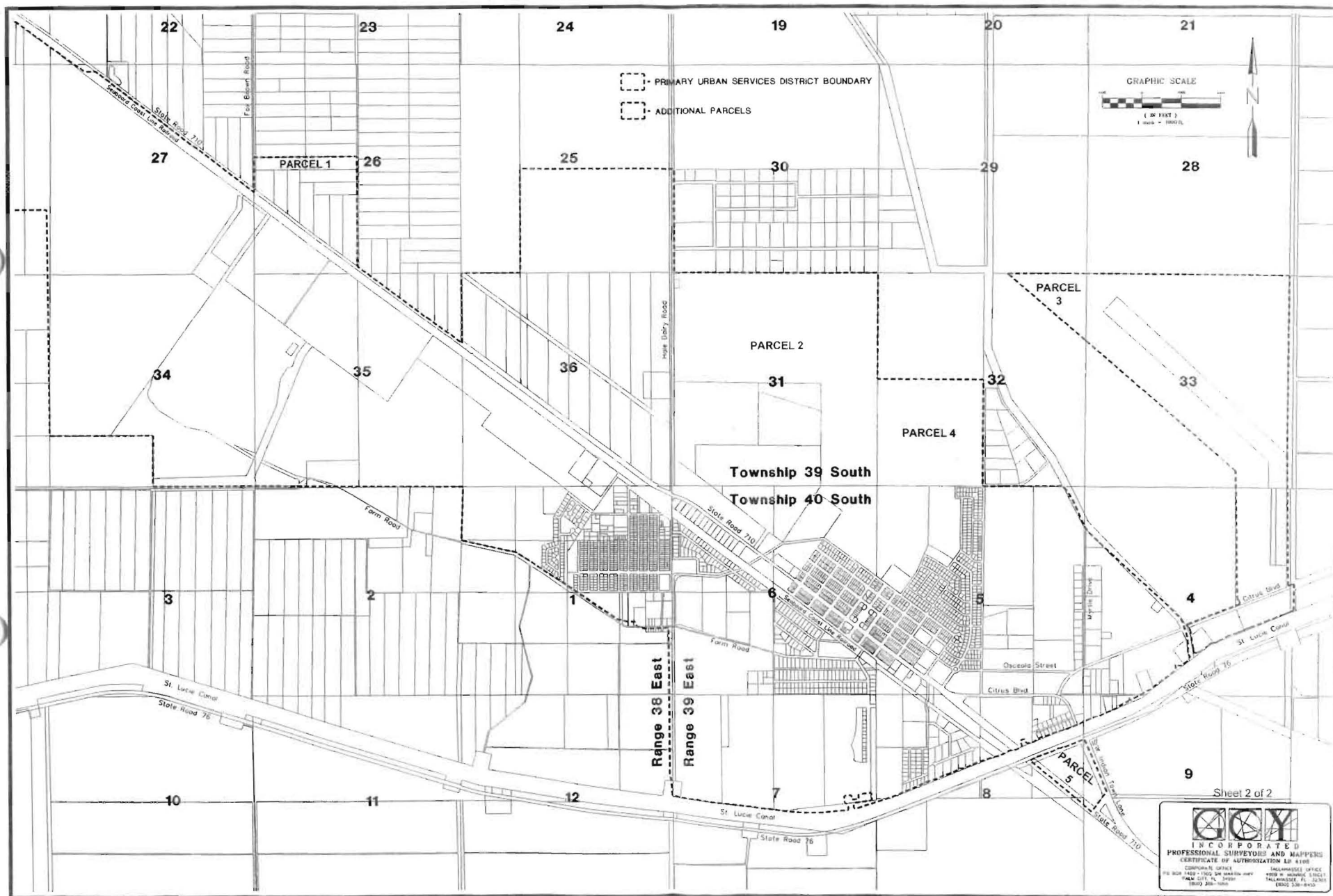
