SPRINT'S MOTION TO ACCEPT LATE-FILED DISCOVERY OBJECTIONS

COMES NOW Sprint-Florida, Incorporated ("Sprint") and files this Motion requesting that the Commission, through the Prehearing Officer, accept Sprint's Latefiled Discovery Objections. In support Sprint states as follows:

- KMC served Sprint with is Second Interrogatories and Second Request for Production of Documents via e-mail on July 30, 2004.
