# PROGRESS ENERGY FLORIDA' PETITION FOR APPROVAL OF ENVIRONMENTAL COST RECOVERY TRUE-UP AND ENVIRONMENTAL COST RECOVERY FACTORS FOR THE PERIOD JANUARY 2005 to DECEMBER 2005

Progress Energy Florida, Inc. ("PEF" or "the Company"), hereby petitions for approval of its environmental cost recovery true-up and proposed environmental cost recovery factors for the period January 2005 to December 2005. In support of this Petition, PEF states:

- 1. As explained in the pre-filed testimony and exhibits of Javier Portuondo, PEF's total true-up applicable for this period is an under-recovery of \$18,075,829. This consists of the final true-up over-recovery of \$951,437 for the period from January through December 2003 and an estimated true-up under-recovery of \$19,027,266 for the current period of January 2004 through December 2004. The detailed calculation supporting the estimated true-up was provided on *revised* Forms 42-1E through 42-8E of Revised Exhibit No. \_\_ (JP-2) filed with the Commission on September 3, 2004, as a substitute for Exhibit No. \_\_ (JP-2) originally filed on August 4, 2004.
- 2. As explained in Mr. Portuondo's testimony of September 3, 2004, and shown in Form 42-1P of Exhibit No. \_\_ (JP-3), the total projected jurisdictional capital and O&M costs for the period January 2005 to December 2005 are \$30,504,449.

- 3. PEF's proposed Environmental Cost Recovery (ECR) factors for the period January 2005 to December 2005, which are designed to recover the 2003 final true-up, the estimated 2004 estimated/actual true-up, and projected 2005 costs, are presented for the Commission's review and approval in Mr. Portuondo's testimony of September 3, 2004. The ECR factors were calculated as shown on Forms 42-6P and 42-7P of Exhibit \_\_ (JP-3) to Mr. Portuondo's testimony.
- 4. The environmental cost recovery true-up and proposed environmental cost recovery factors presented in Mr. Portuondo's testimony and exhibits are consistent with the provisions of Section 366.8255, Florida Statutes, and with prior rulings by the Commission.

WHEREFORE, Progress Energy Florida, Inc., respectfully requests that the Commission approve the Company's environmental cost recovery true-up and proposed environmental cost recovery factors for the period January 2005 through December 2005 as set forth in the testimony and supporting exhibits of Javier Portuondo filed on September 3, 2004.
