MOTION OF POWER SYSTEMS MANUFACTURING, LLC AND TOM CHURBUCK TO REMOVE ISSUES RELATED TO PROPOSED UNIT POWER SALES AGREEMENTS FROM THE FUEL ADJUSTMENT DOCKET AND NOTICE OF JOINDER

Power Systems Manufacturing, LLC ("Power Systems") and Tom Churbuck ("Churbuck"), both of whom have filed Petitions to Intervene in this proceeding, file this motion pursuant to rule 28-106.204, Florida Administrative Code, to remove issues related to the proposed Unit Power Sales ("UPS") agreements between Florida Power and Light Company ("FPL") and Southern Company ("Southern") in this docket to a separate docket, so that parties and the Commission will have adequate time within which to analyze them thoroughly. Power Systems and Churbuck also give notice of their joinder of the Joint Motion of the Citizens of the State of Florida and the Florida Industrial Power Users Group to Remove Issues Related to Proposed Unit Power Sales Agreements From the Fuel Adjustment Docket filed with this Commission on October 4, 2004. Power Systems and Churbuck join in the Joint Motion of Public Counsel and Florida Industrial Power Users Group, only as it relates to the three contracts with subsidiaries of the Southern Company for which FPL

FPL executed these contracts on August 11, 2004 and filed testimony seeking approval of those contracts on September 9, 2004. The compressed time frames contained within this docket do GCL not provide adequate time to thoroughly and completely conduct discovery and evaluate the issues raised by FPL's request for approval of these contracts. Thus, Power Systems and Churbuck seek the RCA SCR SEC DOCUMENT NUMBER 1.
