On October 4, 2004, Tampa Elecctric Company (TECO) filed its request for confidential classification for Document No. 10650-04. This document is TECO's answers to Commission Staff's first set of interrogatories (Nos 1-7)

TECO contends that disclosure of some of the highlighted information in the document would reveal the identities of particular cogenerators who are also customers of TECO. TECO has a policy of not disclosing individual customer information in order to protect any privacy claims or desires they may have. These customers might have proprietary business reasons for not having their identities as sellers of electric power to TECO made public.

Other information discloses the amount and prices of Tampa Electric's actual and expected power purchases for 2004 and expected purchases for 2005 from cogenerators and other suppliers. TECO indicates this information is not disclosed in this degree of detail anywhere else in information publicly submitted by TECO. The information in question concerns contractual data, the disclosure of which would impair the efforts of TECO to contract for goods and services on favorable terms. It is also information relating to competitive interests of TECO, the disclosure of which would impair its competitive business. The information could be used by wholesale competitors and competitive suppliers of power to TECO to model the company's system and/or to affect the company's purchases from third party suppliers. As -such, the information in question is entitled to confidential treatment pursuant to Section 366.093(3)(d) and (e), Florida Statutes.
