7	Q.	PLEASE STATE YOUR NAME AND ADDRESS.
8	A.	My name is Hasit Patel. I reside at 1533 Haverhill Drive, New Port Richey,
9		FL 34655.
10		
11	Q.	WHICH UTILITY SUPPLIES YOUR DRINKING WATER AND
12		SEWER SERVICE AND HOW LONG HAVE YOU BEEN A
13		CUSTOMER OF THE UTILITY?
14	A.	Aloha Utilities, Inc supplies my drinking water. I have been a customer since
15		July, 1998.
16		
17	Q.	ARE YOU SATISFIED WITH THE QUALITY OF WATER IN YOUR
18		DOMESTIC PLUMBING?
19	A.	No. There is a black discoloration in the water at times and sometimes I have
20		to let the water run before it is clear. The water also smells like bad eggs.
21		The problem is most noticeable in taps that have not been used for sometime.

1	Q.	DO YOU DRINK WATER FROM YOUR TAPS? IF NOT, WHY NOT?
2	A.	No, I do not drink water from the tap directly. I have had a Reverse Osmosis
3		Filter installed in my house since the day we moved into our house. We do
4		not drink water directly from the taps. After having seen "black discoloration
5		in the water", I don't think anybody would want to drink water from the tap!
6		In addition the water does smell at times like bad eggs.
7		
8	Q.	WHAT IS IT THAT DISTRESSES YOU ABOUT THE QUALITY OF
9		WATER?
10	A.	For 6 years (since I have moved into my current residence) Aloha has been
1		saying that the quality of the water is good according to their report, but we
12		keep getting black water. I have talked to other friends and relatives living in
13		other counties and areas that have different utilities and they do not experience
14		the problem. Why is it that other utility customers do not experience the same
15		problem whereas Aloha customers do? The black water and the bad eggs
16		smell is what distresses me most about the quality of the water.
17		
8	Q.	HOW FREQUENTLY DO YOU EXPERIENCE POOR QUALITY?
9	A.	The discoloration is present most of the time. It is most prevalent on faucets
20		that have not been operated for some time for example in the Jacuzzi. The
21		sediment builds up in the toilet tanks and in the hot water tank
22		
23	Q.	UNDER WHAT CIRCUMSTANCES OF USE HAVE YOU
24		EXPERIENCED POOR QUALITY?

1	A.	In all the faucets and including the ice dispenser. We do not always use one
2		of our showers and usually have to run the taps for a while to get rid of the
3		black sediment build up as well as the smell before the water can be used.
4		
5	Q.	WHAT KIND OF PIPES DO YOU HAVE?
6	A.	Cooper. The whole house plumbing is copper.
7		
8	Q.	DO YOU HAVE A WATER CONDITIONING APPLICANCES. IF SO
9		WHAT KIND?
10	A.	I have a water softener installed as I prefer soft water for cleaning and heating
11		purposes.
12		
13	Q.	DO YOU USE ANY TYPES OF FILTERS?
14	A.	No. Currently do not use any types of filter but am contemplating a device to
15		install at the main inlet to reduce the blackness of the water. One of the
16		homeowners in our sub-division has installed a device and has found a
17		reduction in the blackness of the water.
18		
19	Q.	HOW DOES THE POOR QUALITY OF WATER AFFECT YOU AND
20		YOUR FAMILY?
21	A.	It has been embarrassing when we have had guests who have stayed overnight
22		and have had to let the water run for a few minutes before they could take a
23		shower because of the black water and the smell. I had to explain to the
24		guests that we are experiencing this problem with the water. On several

1		occasions we have had to do the laundry as well as run the dishwasher twice
2		as the laundry was black and the dishes came out black. I have to regularly
3		clean out the toilet tanks to remove the black deposits in the tanks. It is
4		frustrating that this issue has not been resolved for such a long time.
5		
6	Q.	HAVE YOU MADE ENQUIRIES ABOUT THE QUALITY OF WATER
7		THAT CUSTOMERS OF OTHER UTILITIES IN THE
8		NEIGHBORING AREAS RECEIVE?
9	A.	I have asked other friends and family members living in neighboring areas
10		that are not customers of Aloha and they do not experience this problem of
11		black water or the smell in the water.
12		
13	Q.	WHAT HAS BEEN YOUR EXPERIENCE OF THE QUALITY OF
14		WATER IN DOMESTIC PIPES, IF YOU HAVE LIVED IN OTHER
15		PARTS OF OUR STATE OR OTHER STATES?
16	A.	I have never seen this problem of black water. In fact I only heard about the
17		black water issue when I moved to my current residence.
18		
19	Q.	WHO DO YOU THINK SHOULD TAKE THE PRIMARY INITIATIVE
20		IN IMPROVING WATER QUALITY?
21	A.	I think the provider has to ensure that the quality of the water is improved for
22		its customers. My belief is that the problem should be fixed at the source as
23		this water is being provided to all the users

1	Q.	IF A REASONABLE INCREASE IN COST IS NECESSARY TO
2		IMPROVE WATER QUALITY, WILL YOU BE WILLING TO
3		ACCEPT AN INCREASE IN WATER RATES SIMILAR TO WHAT
4		NEIGHBORING UTILITIES CHARGE?
5	A.	Yes, I would be willing to accept an increase in rates as long there is a
6		guaranteed improvement in the water quality. I understand that the black and
7		smelly nature of the water can be eliminated if a certain element is removed
8		from the water which is the primary cause of the problem.
9		
10	Q.	DOES THAT CONCLUDE YOUR TESTIMONY?
11	A.	Yes.
