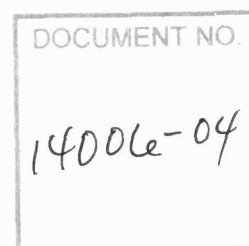

In the above agreement, in your transmittal letter and petition, the underlying agreement is incorrectly labeled as an interim interconnection agreement. The underlying agreement, 001274-TP, contains interconnection, unbundling, resale, and collocation elements.

There are two appendices in the filing and both appear as Appendix 1. They are shown as Florida-11/24/03, and Florida 050703. The second one follows the underlying agreement, so I assume the second appendix is related to that agreement.

To fix this agreement, file a corrected transmittal letter indicating the agreement contains all the elements of the underlying agreement. Also, please clarify which appendix applies to this agreement.

To avoid confusion in future filings, please number each page in the filing sequentially. Also, when filing an adoption, it is not necessary to file the underlying agreement being adopted because it is already on file with the Commission.

I'm changing the memo and close dates on this filing to May 24th and 25th respectively to allow you time to file the corrected letter and clarification.
