#### Item 2. Acquisition or Disposition of Assets.

On June 23, 2004, XO Communications, Inc. ("XO") announced that itcompleted its acquisition of the purchase of substantially all of the assets of Allegiance Telecom, Inc. for approximately \$322.0 million in cash, including\$11 million of adjustments for working capital, and 45.4 million shares of XOcommon stock. The cash portion of the purchase price was funded out of XOCommunication's working capital. The terms of the purchase agreement, includingthe purchase price, were determined through arms-length negotiations between the parties thereto. Allegiance is a facilities-based national local exchangecarrier that provides integrated telecommunications services to business, government and other institutional users in 36 major metropolitan areas across the United States.
