

Pursuant to Commission Rule 25-30.550, Florida Administrative Code, enclosed is a copy of an Agreement for Wastewater Service entered into between Mid-County Services, Inc., and Coastal Builders, Inc., to provide wastewater service to Highland Woods, Phase 3. Mid-County Services' wastewater treatment plant has a permitted capacity of 0.900 mgd. The current treatment plant-connected load is approximately 0.702 mgd, and this Wastewater Agreement is for approximately 5,600 gallons a day. There is sufficient capacity in Mid-County Services' existing plant to provide wastewater service pursuant to this Wastewater Agreement. This Wastewater Agreement will have no noticeable impact on the Utility's rates due to the amount of small demand being placed on the Mid-County Services' wastewater system, and resultant revenues.
