RE: Docket No. 050154-TX, Petition for Expedited Review of Code Denial by the Number Pooling Administrator for the Tampa Central Rate Center (TampaCen), by SBC Telecom, Inc. (SBCT) *Wm h [unclear] CSB*

On February 25, 2005, SBCT filed a petition requesting that the Commission overturn NeuStar's decision to deny numbering resources for the Tampa switch (TAMTFLTWIMD) located in the Tampa Central rate center. In accordance with Commission Order PSC-02-0352-PAA-TL, which approved an expedited process for code denials, we have examined the SBCT petition, along with the confidential supplemental information, and have determined the following:

- 1) The carrier has demonstrated that it has customers in need of immediate numbering resources;
- 2) The carrier has shown that it will be unable to provide services to potential customers because of the Pooling Administrator's denial of the numbering resources;
- 3) Potential customers cannot obtain service from the provider of his/her choice because the carrier does not have the numbers available.
