Pursuant to our prior commitment with the Florida Public Service Commission, I am providing to you and all other parties to this proceeding our status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County for the month of March, 2005.

During the month of March, Orange County and the City of Apopka have continued their efforts from last month to work toward finalizing the new draft of the Orange County/Zellwood Asset Purchase Agreement sent for review by each of them in December. The new draft agreement will implement the agreed plan among Zellwood, Orange County, and Apopka to have Apopka utilize capacity in its treatment and supply facilities to provide the wholesale water and wastewater services to Zellwood after the closing between Zellwood and Orange County.
