

#### Dear Mike:

Florida Gas Transmission Company ("FGT") hereby submits the following Proposal in response to Florida Municipal Power Agency's ("FMPA") request regarding expansion of the FGT system to provide incremental firm service capacity to the proposed Treasure Coast Energy Center plant site. All terms presented below are for discussion purposes only and do not constitute an offer or create any binding agreement. Any final agreement arising out of this proposal is subject to Board approval. All terms of discussion shall be considered confidential between FMPA and FGT.

- 1. **Type of Service:** FGT proposes to provide FMPA with Firm Transportation Service for incremental transportation capacity under Rate Schedule FTS-2.
- 2. Transportation Contract Capacity: 40,000 MMBtu/day (seasonal contract volumes are possible depending on project scope)
- 3. **Firm Service Delivery Capability:** FGT proposes the following firm service delivery capability at the FMPA Treasure Coast Energy Center plant site.

Maximum Daily Quantity: 40,000 Maximum Hourly Quantity: 2,400

Minimum Delivery Pressure: 525 psig

- 4. Supply Area Options: The potential supply area receipt point options would include:
  - FGT/SNG-Cypress Pipeline Interconnect
  - Destin / Mobile Bay
  - Available capacity resulting from turn-back capacity in the expansion project

FMPA will have alternate receipt point access to all receipt points on the FGT system.

- 5. Term of Service for Transportation Capacity: The proposed term of the firm service agreement shall have a minimum primary term of twenty (20) years.
- 6. Transportation Rate: The rate shall be the Rate Schedule FTS-2 rate set forth in FGT's FERC Gas Tariff.
- 7. Firm Service Flexibility: FMPA will have the flexibility to shift the Treasure Coast Energy Center volumes on an alternate firm basis to all FMPA plants on the FGT system.
  - FMPA will also have the flexibility to shift the Treasure Coast Energy Center volumes to all delivery points on the FGT system on an alternate firm basis.
- 8. **Expansion / Open Season:** The addition of any incremental mainline firm capacity will require FGT to conduct an open season process, in which any turnback of existing firm capacity and requests for new incremental capacity must be considered.
- 9. Approvals: Any final agreements arising out of this proposal are subject to Board Approval and the receipt of all necessary permits and applicable state and federal regulatory approvals in a form acceptable to FGT.
