BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. ("BellSouth"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification and states the following:

1. On June 3, 2005, the Florida Public Service Commission (hereinafter "Commission"), requested that BellSouth provide certain information to help the Commission evaluate the status of competition in the telecommunications industry. This information is being provided in connection with the Commission's request.
2. On August 1, 2005 BellSouth filed its 1st supplemental response to the Commission's 2005 ILEC Report. BellSouth's 1st supplemental response to Tables 2 and 3 include confidential business information that is considered proprietary to BellSouth.
3. Because the information provided in BellSouth's response contains proprietary information, BellSouth is now filing this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of this information without delay. The original of this notice has been filed with the Division of Records and Reporting. BellSouth will be filing a Request for Confidential Classification within 21 days of the filing of this Notice of Intent.


