

# IMPORTANT NOTICE EFFECTIVE IMMEDIATELY

In order to improve this court's efficiency in receiving and reviewing appellate briefs of the parties, the Third District Court of Appeal is requesting that when an attorney files an appellate brief with this court, the attorney also submits a copy of the brief as an attachment to an e-mail directed to the court's public e-mail address at **3dca@flcourts.org**.

The brief may be submitted via e-mail in any word processing format compatible with MS Word; however, because the court's word processing system is MS Word, the court would prefer that the brief be submitted as a MS Word document utilizing the following steps:

(1) Save the brief as a <u>single</u> file in MS Word format. The <u>single</u> file should be named as follows:

Case number followed by type of brief.doc

Naming examples for each type of brief using case no. 03-726:

Answer Brief	03-726ans.doc
Reply Brief	03-726rep.doc
Cross Reply Brief	03-726cro.doc

(2) Attach the file to an e-mail which states the style of the case, case number, and type of brief. Send the e-mail and attachment to the court's public e-mail address at <u>3dca@flcourts.org</u>.

This change does not affect the number of paper copies of briefs that are required to be filed pursuant to Florida Rule of Appellate Procedure 9.210(h)(2). The change also does not affect requirements of when the original and copies of the brief must be received at the court by hand delivery or mail.

The voluntary submission of briefs via e-mail is replacing the voluntary submission of briefs on diskettes. However, if the attorney does not have the capability of submitting a brief via e-mail, the brief may be submitted on a diskette.

We stress that the voluntary e-mailing of the brief will be greatly appreciated.

<u>NOTICE OF APPEAL</u>: File the original in the lower court with \$300.00 filing fee payable to Clerk, Third District Court of Appeal. Include the lower court number and judge's name in the upper right hand corner. There is a fee for the lower court, payable to the lower court. In the certificate of service, please indicate the name of the attorneys, their firms and who represents whom. Also include the Florida Bar number of the filing attorney.

<u>PETITIONS</u>: All original writs: file an original and three copies with \$300.00 filing fee payable to Clerk, Third District Court of Appeal. Petitions should be securely bound on the top or upper left hand corner. Include the lower court number and judge's name in the upper right corner. In the certificate of service, please indicate who represents whom and the Florida Bar number of the filing attorney. Include pre-addressed, stamped envelopes for all parties including yourself. Habeas Corpus or appeals there from do not require a filing fee.

APPENDIX TO PETITIONS OR BRIEFS: Original and three copies, securely bound on the top or upper left hand corner AND SHOULD BE FILED SEPARATE FROM THE PETITION OR BRIEF.

RESPONSES: Original writs: original and three copies. Motions: original only.

MOTIONS FOR EXTENSION OF TIME FOR BRIEFS ONLY: Original and copies, for all parties in the certificate of service, including yourself. Include pre-addressed, stamped envelopes for all parties including yourself.

<u>BRIEFS</u>: Original and three copies, securely bound on the left-hand side or upper left hand corner and in a manner that will allow them to lie flat when opened. No specific color folder is required.

<u>RECORD</u>: When providing directions for inclusion of exhibits in the record on appeal, do not designate any tangible evidence without prior permission of the Court. This applies especially to drugs, firearms, explosives, x-rays and heavy or bulky items such as large maps, photographs and graphs.

NOTICE TO INVOKE TO THE SUPREME COURT: Original with two copies and a copy of the opinion and order denying rehearing with \$300.00 filing fee payable to Clerk, Supreme Court of Florida.

<u>COPIES</u>: Copies are made by court personnel only. Please call to be sure the file is available for viewing. The copying fee is \$1.00 per page. We require <u>exact cash</u> or law firm check. We do not mail copies unless both copies and postage have been prepaid. We prefer that you come in the afternoon to make copies.
