**BELLSOUTH TELECOMMUNICATIONS, INC.'S
REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code and Section 364.183, Florida Statutes, files this Request for Specified Confidential Classification.

1. On November 22, 2005, BellSouth filed its Responses to the Florida Public Service Commission Staff's (hereinafter "Staff") First Set of Interrogatories (Nos. 1-38) and First Request for Production of Documents (Nos. 1-9). MCImetro Access Transmission Services LLC ("MCI") has advised BST that portions of BellSouth's responses contain MCI's confidential information. On November 22, 2005 BellSouth also filed a Notice of Intent to Request Specified Confidential Classification for the information MCI claims is confidential.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth files this Request for Specified Confidential Classification, because MCI claims that certain information produced by BellSouth for Staff's First Request for Production, No. 2 contains MCI's confidential business information. Therefore, to honor MCI's request and beliefs and in an abundance of caution, BellSouth submits that such information should be classified as MCI's confidential business information pursuant to

Section 364.24 and Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

3. Attachment A to BellSouth's Request for Confidential Classification contains an explanation of the proprietary information and identifies the location of the information designated by MCI as confidential.

4. Attachment B to BellSouth's Request for Confidential Classification is redacted copies of the document containing the confidential information.

5. Attachment C to BellSouth's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.

6. The original of this Request was filed today with the Division of the Commission Clerk and Administrative Services and a copy was served on the Parties.

WHEREFORE, based on the foregoing, BellSouth respectfully requests that, pursuant to Section 364.183, Florida Statutes, the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.
