SECTION 63.71 APPLICATION

PT-1 Long Distance, Inc. and PT-1 Communications, Inc. ("PT-1" or "Applicants") hereby seek authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended (the "Act"), 47 U.S.C. § 214, and Section 63.71 of the Commission's Rules, 47 C.F.R. § 63.71, to discontinue their provision of certain domestic telecommunications services – namely, presubscribed long distance services – to end users in all states where Applicants are authorized to provide telecommunications services.

Applicants have notified their customers of this discontinuance via first class mail with approximately sixty (60) days' notice, so that the customers may secure like services from another carrier prior to PT-1's discontinuance of service. There are approximately 5000 customers that will be affected by this discontinuance. All of the customers have adequate alternative services available to them from various other interexchange carriers.

PT-1 Long Distance, Inc. offers service in the following jurisdictions: Alabama, Arizona, California, Colorado, Delaware, District of Columbia, Florida, Georgia, Illinois, Indiana, Massachusetts, Maryland, Michigan, Minnesota, North Carolina, New Jersey, New Mexico, Nevada, New York, Ohio, Oregon, Pennsylvania, Rhode Island, Texas, Virginia, Washington, Wisconsin, and West Virginia. In addition, PT-1 Communications, Inc. is certified to provide services in all of the states listed above, but all services to customers are provided by PT-1 Long Distance, Inc.

Applicants provide the following information pursuant to Section 63.71 of the Commission's Rules:

- 1. <u>Name and Address of the Carrier:</u> PT-1 Long Distance, Inc. is a wholly-owned subsidiary of PT-1 Communications, Inc., and both companies are headquartered at 30-50 Whitestone Expressway, Flushing, NY 11354.
- 2. <u>Date of Planned Service Discontinuance, Reduction or Impairment</u>: The Applicants plan to discontinue service to the affected customers in the states listed in footnote 1 above as of January 31, 2006. Applicants understand that this application will be automatically granted on the 31st day after public notice of filing unless the Commission notifies the Applicants to the contrary.
- 3. <u>Points of Geographic Areas of Service Affected</u>: Applicants will discontinue the provision of the services listed above to the affected customers in the states listed in footnote 1 above.
- 4. <u>Brief Description of Type of Service Affected</u>: PT-1 intends to discontinue the provision of presubscribed long distance services to end users.
- 5. <u>Brief Description of the Dates and Methods of Notice to All Affected</u>

 <u>Customers</u>: Applicants provided written customer notice in accordance with the requirements of Section 63.71(a) of the Commission's Rules by notice dated November 1, 2005. Notice was sent by first class mail to the affected customers on November 1, 2005 A copy of the notice is appended hereto as *Exhibit A*.
- 6. Whether the Carrier is Considered Dominant or Non-dominant with Respect to the Service to be Discontinued, Reduced or Impaired: Applicants are considered non-dominant carriers with respect to the affected services.

In accordance with Section 63.71 of the Commission's Rules, a copy of this Application is being mailed to the Governors and public services commissions of the states listed above, and to the Special Assistant for Telecommunications for the Secretary of Defense, concurrently with the filing of this application.
