On September 22, 2004, Ranch Mobile WWTP, Inc. (Ranch Mobile or utility) filed a petition for approval of a permanent rate increase with the Florida Public Service Commission (PSC or Commission). Ranch Mobile is a wastewater utility providing service to three mobile home park customers in Pinellas County.

Ranch Mobile is requesting approval of a permanent rate increase of \$67,283 or 36.28% on an annual basis. The utility did not request interim rates. By Order No. PSC-04-1097-PCO-SU issued November 5, 2004, the PSC suspended the utility's requested final rates. The utility has requested this increase because of a sewer line rehabilitation capital project. Ranch Mobile was last granted a rate increase by Order No. 24888, issued August 7, 1991.

The current rate case is being processed under the PSC's "Proposed Agency Action" (PAA) procedure. Under the PAA process, the case will not be set for a formal hearing unless a timely protest to the Commission's proposed agency action is filed.

As part of the process of evaluating Ranch Mobile's request, the PSC staff conducts a customer meeting to allow customers the opportunity to provide input into the rate setting process. Customer comments are an integral part of the process and will assist the Commissioners in reaching their decision. The utility's records will be audited by PSC staff for compliance with the applicable rules and orders. In addition, a PSC staff engineer will conduct a field investigation of the utility's plant and service area. In accordance with Florida Statutes, the Commissioners will consider the utility's quality of service and other matters in this case.

PSC staff is scheduled to make a recommendation to the Commission on January 20, 2005. The Commissioners are expected to vote on this matter at the February 1, 2005, Agenda Conference.
