Indiantown Company, Inc. (Indiantown or utility) is a water and wastewater utility providing service to approximately 1,806 water and 1,686 wastewater customers in Martin County. On August 18, 2004, Indiantown filed an application with the Florida Public Service Commission for approval of interim and permanent water and wastewater rate increases. On November 2, 2004, the utility amended its application to correct filing deficiencies.

On December 7, 2004, the Commission approved interim revenue increases of \$56,022 (9.17%) for water and \$93,702 (10.76%) for wastewater. The interim rate increases are subject to refund, with interest, until the Commission completes its investigation on the final rate request. The utility's requested final water and wastewater revenue increases are \$189,765 (31.05%) and \$338,771 (38.89%), respectively.

As part of the process of evaluating Indiantown's request, the PSC staff conducts a customer meeting to allow customers the opportunity to provide input into the rate setting process. Customer comments are an integral part of the process and will assist the Commissioners

in reaching their decision. The utility's records will be audited by PSC staff for compliance with the applicable rules and orders. In addition, a PSC staff engineer will conduct a field investigation of the utility's plant and service area. In accordance with Florida Statutes, the Commissioners will consider the utility's quality of service and other matters in this case.

PSC staff is scheduled to make a recommendation to the Commission on March 17, 2005. The Commissioners are expected to vote on this matter at the March 29, 2005, Agenda Conference.

The current rate case is being processed under the PSC's "Proposed Agency Action" (PAA) procedure. Under the PAA process, the case will not be set for a formal hearing unless a timely protest to the Commission's proposed agency action is filed.
