

- 2. No permits have been applied for at this time from the Florida Department of Environmental Protection. Property owners in the area are on wells and septic tanks. There are many vacant lots in the area that will require water service when developed and we are trying to put ourselves in a position to be able to supply them when the need arises at which time FDEP permits will then be applied for.
