On May 9, 2006, BellSouth Telecommunications, Inc. (BellSouth) filed a request for additional numbering resources from the Number Pooling Administrator (NeuStar), for the Jacksonville exchange, San Marco (JCVLFLSMDS0) switch. BellSouth requested a NPA NXX code to meet a customer's request. The customer requested the format, NXX-XX2, 3, 4, 5, 6, or 7. On May 9, 2006, BellSouth's request for a full NXX code of numbers was denied because it did not meet the months-to-exhaust utilization criteria required for additional numbering resources.

On May 25, 2006, BellSouth filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the BellSouth petition and has determined the following:
