Re: Request for Cancellation of CLEC Certificate of Public Convenience and Necessity ("CNN") No. 8132 and Acknowledgement of Cancellation of IXC Registration No. TJ805 held by Utilities Commission, New Smyrna Beach dba Sparks Communications as of August 1, 2006

Dear Ms. Bayó:

The Utilities Commission, New Smyrna Beach ("Applicant") respectfully seeks cancellation of the captioned CNN^1 and Registration effective August 1, 2006. In addition, upon exit from the market, Applicant requests that all price list and tariffs be cancelled.

Due to continuing business challenges, Applicant will cease providing telecommunications services in the State of Florida upon receipt of all required state and federal approval. As required by the Commission, notice of Applicant's intent has been sent to all current Florida customers (see attached notice, mailed to customers between May 30 and June 1, 2006). As noted in the attachment, Applicant will work with customers to facilitate the transition to new carriers. In addition, the attached notification describes how Applicant will handle customer deposits and final bills.

To the extent that Applicant is not already current in the payment of all applicable regulatory assessments and fees, it shall become current on or before August 1, 2006.



Due to continuing business challenges, we regret to inform you that the Utilities Commission, City of New Smyrna Beach ("New Smyrna Communications") plans to discontinue the services it offers in your geographic area. As a result, this letter is to notify you we will **discontinue any and all LOCAL**, **DOMESTIC AND INTERNATIONAL LONG DISTANCE, TOLL FREE, PRIVATE LINE, and any other service you receive in your current service location as of August 1, 2006.**

You must select a new service provider(s) as soon as possible to avoid any interruption of service. Please do not delay in arranging for a new service provider as some carriers may require several weeks to install new services. If you do not choose a new carrier by August 1, 2006, you risk losing communication service. To assist in your service conversion, in the text box above is a list of each telephone number associated with your account, which you can provide to the new carrier that you have selected. To help avoid service disruption, please check carefully that all service types you currently have with New Smyrna Communications (local, long distance, toll free, calling card, and/or any other services) are moved to your new carrier. Once you have chosen your new provider, New Smyrna Communications will work with the carrier you have selected to assist in the transition of your service. Any deposit on your account that is held by New Smyrna Communications will be applied to your final bill. All attempts will be made to send you a refund within forty-five (45) calendar days of issuance of the final bill amount.

We have informed the Federal Communications Commission ("FCC") of this discontinuance. The FCC permits customers to object to discontinuance of their service by a telecommunications provider. As provided in the FCC's rule 47 CFR 63.71:

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments within 15 days after receipt of this notification. Address them to the Federal Communications Commission, Washington, D.C. 20554, referencing the Section 63.71 Application of Utilities Commission, City of New Smyma Beach, dba New Smyma Communications. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
