Please accept this letter as notice of the City of Panama City Beach's intent to participate as a party in PSC Docket No. 060172-EU, In Re: Proposed Rules Governing Placement of New Electric Distribution Facilities Underground, and Conversion of Existing Overhead Distribution Facilities To Underground Facilities, To Address Effects of Extreme Weather Events, and in PSC Docket No. 060173-EU, In Re: Proposed Amendments to Rules Regarding Overhead Electric Facilities To Allow More Stringent Construction Standards Than Required by the National Electrical Safety Code. The City of Panama City Beach ("City") has been actively considering underground conversion projects that would be directly affected by the Commission's rules, as those rules will determine the Contributions in Aid of Construction for overhead-to-underground conversion projects.
