staff recommendation to amend Rule 25-4.0161 on telecommunications companies' regulatory assessment fees. The recommendation is to change the minimum amount, minimum annual amount of regulatory assessment fees that each telecommunications company must pay.

CHAIRMAN EDGAR: Thank you.

COMMISSIONER DEASON: Madam Chairman, I have a question.

As is contained in the recommendation, there is the possibility, as is recognized, that there may be some entities which currently have a certificate that may just decide to, I guess to no longer be certified so that they'd give up their certificate because of the increase in these fees.

Do we have any, any feel for what that number may be and what the financial -- the revenue stream impact of that would be?

MR. KENNEDY: Ray Kennedy, Commission staff.

I would base the answer on our historical cancellations for nonpayment of RAF. For example, we had over 200 companies this past year that didn't pay the RAF. I expect

those trends to continue. We see in excess of generally around 1 2 200 or more every year, so I think we experienced about the 3 same amount. Although it could be more because people who do not have any business may elect to just cancel and then come 4 5 back later once they establish a customer base. 6 COMMISSIONER DEASON: Well, people that cancel a 7 certificate do have -- if they cancel it in good standing, they 8 have the ability to reapply for a certificate at a later date; right? 9 10 MR. KENNEDY: They certainly do. 11 COMMISSIONER DEASON: And the fee levels, there's 12 been, been effort to set those levels at closer to the cost of regulating, administering the certificate, the certificate 13 14 process and the collection of fees and that sort; is that 15 correct? ~ 16 MR. KENNEDY: That's correct. 17 COMMISSIONER DEASON: Okay. That's all that I have, Madam Chairman. 18 19 CHAIRMAN EDGAR: Commissioners, any further 20 questions? 21 COMMISSIONER DEASON: I move staff's recommendation. 22 COMMISSIONER CARTER: Second. 23 CHAIRMAN EDGAR: A motion and a second for the staff 24 recommendation on Item 3.
