On December 1, 2006, NuVox Communications, Inc. (NuVox) requested additional numbering resources from NeuStar for the Tampa Rate Center (WNHNFLBUDS0) Winter Haven switch. To meet the request of a customer for 10,000 consecutive numbers, NuVox requested a full new NXX code. On December 1, 2006, NuVox's request for the additional numbering resources was denied because it did not meet the months-to-exhaust utilization criteria required for additional numbering resources.

On December 8, 2006, NuVox filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the NuVox petition and has determined the following:

- 1. The carrier has demonstrated that it has a customer in need of numbering resources;
- 2. The carrier has shown that it is unable to provide services to this potential customer because of NeuStar's denial of the numbering resources;
